Notice to Our Valued Customers

Re: Adjustment to China Customs Advanced Manifest (CCAM).

Please be advised that the **General Administration of Customs China (GACC)** has issued Announcement No.56 [2017] to adjust the manifest rules of import and export (**Air and Ocean**) in the country. The adjusted rules, **to be effective on 1st June 2018**, will include the following key points for close attention in future documentation work:

All consignments importing into Mainland China must comply the new regulations by GACC. Shippers are responsible for data accuracy and completion, failure to comply will lead to customs issue, delay delivery and may have to suffer the penalty from local customs.

Action required

- Cargo Description must be complete and accurate (refer Appendix A, Non-Acceptable List from GACC, annex39)
- Postal addresses of shipper and consignee should be at least with Number and street address or PO Box number. Besides, Postal Code (6 digits) is mandatory for addresses in Mainland China.
- Shipper' s contact number (TEL and/or FAX)
